#### **Maidstone Museums; School Visit Risk Assessment**

To help you plan your visit to the museum we have put together a school visit risk assessment. Please use this form for guidance to aid completion of your own school version. Please note that some areas of the assessment will not apply to your group depending on the nature of your visit.

Please be aware that we have lift access to the majority of the building except Natural History and Dinosaurs. Routes when using lift may be longer than step access. As the museum building began life over 500 years ago and has been added to over the centuries there are many different levels, with galleries leading off of galleries.

Pre visits by staff are recommended and welcome due to the layout of the museum and various floor levels due to the age of the building. Pre visits do not need to be booked unless a conversation is required with the Learning Officer. Visit Wed- Sat, 10.00am – 3.30pm term time, Mon-Sat 10.00am – 3.30pm during school holidays.

#### **Further Controls**

- 1) All artefacts and specimens are under the control of the Learning and Events Officer. All handling sessions are supervised and led by members of the Learning Team.
- 2) All museum learning staff and volunteers have been police checked. No other staff/volunteers should be left unaccompanied with children.

Museum buildings	Lost Pupils	The museum has one entrance/exits - at the main reception desk. There is another accessed via the front courtyard – used by schools on their arrival, on the ground floor to the centre of the museum marked on the map. Teachers or pupils should report to the main reception if they lose a member of their group within the museum. They can then be tracked down on the internal camera system.	Pupils must be supervised by school teachers at the recommended ratios (see booking confirmation) Pupils should not be allowed to wander unaccompanied by an adult.	Low
Floor levels and moving around the building	Uneven floors and access to galleries	The museum was built over many centuries resulting in many different floor levels and access to galleries. As such some floors/stone steps may be a little uneven. We have lift access to most areas except the Natural history and Dinosaur galleries.	Pupils should be supervised when moving between galleries and around the building, especially up and down stairs.	Low
First Aiders		Staff for school visits should include at least 1 first aider. We have first aiders on site who will assist if needed.		

## **INTERACTIVE WORKSHOPS**

Object Handling	Contamination	Objects are clean and kept in boxes. Specimens have been scientifically cleaned. Pupils instructed not to put their hands in their mouths.	Teachers are responsible for making sure pupils wash their hands after the workshop. Two sinks are available in the classroom, or those in the toilets can be used.	Low
Object Handling	Cuts or bruised toes	Pupils are told to respect the artefacts and specimens and be careful when handling. They must not stand up when holding any fragile or heavy objects.	Reinforcement of staying seated when handling artefacts by teachers.	Low
Craft activities	Cuts or eye damage from sharp implements such as scissors and clay shaping tools	Pupils are shown how to use the tools correctly in the craft workshop.	Pupils supervised throughout activity by learning team and teachers.	Low


Area	Potential Hazard	Controls	Additional measures required	Risk High Medium Low
Education room/ museum	Pupils overheating or becoming cold	Coats and garments can be left in the education room. The museum is heated, with air conditioning in the temporary exhibition and Japanese Galleries on the first floor. The carriage museum has no heating so extra layers must be worn in winter.	Teachers and parents are responsible for pupils and should ensure they wear suitable clothing.	Low
Lunch Space	Hunger, dehydration and needing rest	A suitable space for lunch should be booked in advance. One of the two education rooms, or Brenchley gardens can also be used. Self led/Visit only bookings are not guaranteed a lunch space if workshop bookings occur on the same day.	Teachers should ensure that a lunch break is scheduled in to the day and pupils have bought their own food and liquids.  No food or drink to be consumed around the museum except in designated areas.  Please note we no longer have a café on site. Nearest coffee shops are in Fremlin Walk. Coffee purchased elsewhere and brought to the museum should have a lid. It can only be consumed on one of the two learning spaces.	Low

#### **Risk Likelihood**

It is the probability that a risk can occur.. Likelihood can be described as high, medium and low.

- High: An injury is expected to occur in most circumstances
- Medium: An injury will probably occur in many circumstances
- Low: An injury may occur at some time

#### **Risk Impact**

It is the potential effect that a risk could have on the person affected

- High: Serious injury or death
- Medium: Significant injury resulting absence
- Low: Minor injury No absence

The combination of likelihood and impact gives us the value for each risk factor
